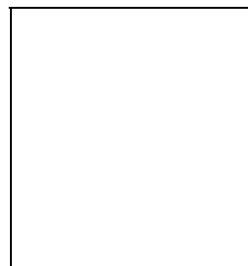

Eligibility of Trainees	- Medical Officer (Ayurveda). - Preference will be given to the candidates who have attended least number of CMEs.
Maximum no. of trainees	30 (Thirty)
Procedure to Apply	- Eligible Medical Officer (Ayurveda) can apply by filling in the enclosed Application form, duly recommended by the Head of the Institute/Controlling Authority. - Application form along with self-certified copies of Employee ID card/Appointment letter, Registration certificate (NCISM/State Council), PAN card, Aadhar Card, and first page of Bank Passbook/ cancelled Cheque should be sent through the mail on or before 25-09-2026 (4:00 pm) - An incomplete application or applications received after the due date will not be considered. The applicants have to scan the entire application along with the relevant documents and send it to cme.neiah@gmail.com as a combined PDF document.
Procedure of Selection	- Guide lines of the RAV CME scheme will be applicable. - Selected participants will be informed by email on or before 05/10/2026
Payment of TA	- Actual fare or up to the fare of AC 2 tier class, whichever is less. - Train tickets must be booked from the Windows of Railways or the IRCTC website. - TATKAL or DYNAMIC PRICING Train Tickets will not be reimbursed. - Reimbursement of the journey performed by road is permissible for places that are not connected by rail. The road mileage will be limited to 2AC rail charges or actual claim or as per Govt. of India rules, whichever is lower. - On production of original bills, food bills note exceeding to Rs. 300/- will be paid for the journey period. No food expenses will be paid if the journey is made by Shatabdi/ Rajdhani/ Durante trains/ Vande Bharat Express. - Payment of TA/DA will be made only at the end of the program, directly to the bank account by electronic transfer. - In case of any epidemic out break and lock down situation, the train ticket and its cancellation charges will be borne by the participant him/herself.
Lodging and Boarding	The trainees will be provided with the best possible lodging and boarding facilities within the budget limits of the CME. Accommodation will be provided on a twin-sharing basis.
Attendance and participation Certificate	- Full Attendance is mandatory for obtaining a participation certificate. - The certificate will be issued at the end of the CME.
